July 30- 2016-Timeline of the flood

6:45 p.m. Rain begins to fall in Ellicott City

7:18 p.m. The NWS issues a flash flood warning as the tributaries of the Patapsco River begin to rise

7:45 p.m. The heaviest rain falls. A total of 6.60 inches of rain falls on Ellicott City within 2 hours. This volume of rain is classified by the NWS as a 'thousand year storm'- there is a 0.1% chance that a storm like this will occur in a single year

8:01 p.m. The first reports of flooding near Ellicott City occurs. Howard County 9-1-1 begins taking calls. By the end of the event it will have received 4x its normal calls. Let's listen to just a few minutes of those calls







Gas leaks, cars and other large debris create safety & access issues











PM in Ellicott City:


- In response to the July 30th flood, PM named Ellicott City one of it's "Six-to-Fix" sites for 2016-2017
- Established a temporary Resource Center on Main Street with two PM staff members to help provide technical preservation assistance and guidance for rebuilding using financial incentives, such as historic tax credits and loans
- Preservation assistance to over 78,000 sq. ft within historic district
- Partnerships were critical to success. PM worked closely with local organizations/non-profits and County government



HEC/PM Revitalization Grant Program

- PM partnered with Historic Ellicott City, Inc. (HEC)
- Open to non-profits, religious institutions, and County agencies
- Eligible projects include: repair and rehabilitation; public programming; and planning projects for historic properties in historic district
- \$50,000 in total funding; individual grants from \$2,500-\$10K

Challenges from a Property Owner's Perspective:


- -Catastrophic property damage, merchandise lost
- -Loss of income as well as rental income
- -Little to no flood insurance reimbursement
- -Challenges with the permitting and review process, who's on first, what resources are available, and what it means to rebuild in a historic district.
- -Application fatigue







Local, State, and Federal Historic Tax Credits





Lessons Learned:

- Get in early immediately after the disaster; establish a network. Reach out to the response teams to make sure preservation is a part of the initial discussion
- Work closely with existing local non-profits or religious groups to form critical partnerships
- Be prepared with supplies (especially dealing with mold), i.e.: hard hats, gloves, ventilator masks, construction vests, water, flashlights, boots, etc.
- Learn to be patient and empathize with property owners
- If possible, have some kind of funding mechanism upfront to assist with initial preservation efforts


